Set-up: 6:30am-8:45am. Please bring your own display materials and protective coverings. The sale is held RAIN or SHINE. No take down before 3pm. Sorry, no parking on the grass by order of the Cumberland Park Board.

Registration Fee: \$40.00 for each 12'X12' space with applications received by May 1.

The fee is nonrefundable unless your application is not accepted. Applications are reviewed and spaces assigned in the order in which they are received, once return vendors spaces have been processed. Notification will begin about April 15. Space assignments will be included with acceptance information. New artists need to submit a stamped, self-addressed envelope with application and include two photos of their art or craft.

General Information: Show size is limited to 50 booths and open to those individuals doing their own fine arts or **handmade** crafts. **No flea market or buy sell items. No mass-produced items**. This show is highly advertised and well attended. If you have

quality work, at reasonable prices, the people in our area will buy. There will be a variety of food stands, a popular used book sale and live entertainment to make a pleasant day for you and your customers. A booth sitter will be available for bathroom and food breaks :)

Sales Tax: Wisconsin Statutes require operators of art fairs to disclose to the Dept. of Revenue the sellers permit number (if available) or the Social Security Number of each vendor selling merchandise. Please fill in Part C of form S-240 (Wisconsin Temporary Event Operator and Seller Information) and enclose with application. If you do not have

a WI Tax Account Number (line 6), you **MUST** fill in line 7 and/or line 8.

(Barron County sales tax is 5.5% and collection is the responsibility of the exhibitor.)
